2 Purpose of this Request for Information (RFI)

- 2.1 The purpose of this RFI is to gather information to help the New Mexico Corrections Department (NMCD) determine the most advantageous telephone system in providing a means of communication between inmates and their families while providing NMCD Central Office the capability to perform oversight and monitoring of such calls.
- 2.2 NMCD is asking a prospective vendor to provide information regarding the following services:
 - A. Vendor will provide a telephone service to inmates for the purpose of allowing contact with families and the community.
 - 1.) The phone system shall allow for both real time and historical monitoring.
 - 2.) The phone system shall alert to key phrases and voice recognition.
 - 3.) The vendor shall provide phone monitoring of at least 10% of phone calls.
 - B. Vendor shall provide tablets to inmates.
 - 1.) The tablets shall be able to provide for e-mail access, downloaded books, magazines, music, rental movies, games, religious materials, photographs, educational materials, and re-entry resources.
 - 2.) The tablets must be able to be remotely reviewed.
 - 3.) E-mails system and the tablet itself must be monitored in manner similar to phone monitoring.
 - 4.) The above services available for the tablets must have a mechanism to reject programs/services that undermine security, public safety and/or recidivism reduction efforts. Items that promote disrespect to law enforcement, that encourage criminality, that give instructions on how to escape, that appeal to prurient interests are examples of those items NMCD would reject.
 - 5.) If possible a privacy mechanism allowing for the storage of legal materials would be advantageous. This would include legal access through a kiosk system where legal research materials could be temporarily downloaded to tablets.
 - C. Vendor shall provide cell phone blocking and cell phone detection devices.
 - D. Drone Detection Devices.
 - E. Video Visitation shall be an option.

This RFI is issued solely for information and planning purposes it does not constitute a Request for Proposal (RFP) or a promise to issue an RFP in the future. 3 Background

3.1 Agency Vision & Mission

Vision

The NMCD shall set the ethical standards and correctional best practices for the statewide corrections community. The NMCD, as an integral part of the criminal justice system, provides public safety, with professionalism, progressive management, and fiscal responsibility, through a continuum of custody, control, supervision, programs, and services for criminal offenders.

Mission

The NMCD adopted this oath as its mission: "We commit to the safety and well-being of the people of New Mexico by doing the right thing, always".

3.2 Agency Description

The Department provides a balanced system approach to corrections from incarceration to community-based supervision with training, education, programs and services that provide opportunities for offenders to successfully transition back to communities. The NMCD must track approximately 26,000 offenders that are under the jurisdiction of the Corrections Department. It is essential for the Department to have high-quality data, tracking and reporting related to the housing, services and programs for offenders.

The Adult Prisons Division has six (6) public and five (5) private prisons statewide. The following map depicts those locations.
