- ◆ Information & Advocacy. Comprehensive information, assistance and advocacy are available to crime victims and their families throughout the Corrections process.

- ◆ Provide referral services to assist victims and victims' families with specific needs in obtaining federal, state and / or community victim resources.

Frequently Asked Questions

What happens to an offender after they are sentenced?

Once sentenced to the New Mexico Corrections Department, the inmate will first go to the Reception and Diagnostic Center in Los Lunas for tests and evaluations. Inmates are then classified to the most appropriate level of custody upon admission. An inmate's custody level is important because it determines the type of institution in which the inmate will be housed. An inmate's custody level could change over time because of length of time served, good behavior, bad behavior, etc. When the custody level changes, so can the inmate's location and it is possible that an inmate may be moved to a different prison.
