## **New Mexico Corrections Department to launch tablets in prison facilities** *The tablets will launch inside NMCD facilities in July.*

**Santa Fe** - The New Mexico Corrections Department (NMCD) is making final preparations ahead of implementation of state-of-the-art “Smart Communications” tablets. They will be used inside all state-operated facilities, with privately contracted locations to follow.

“The introduction of tablets to our populations will transform our ability to deliver information and provide services, while modernizing communication options for inmates and their families,” **said NMCD Cabinet Secretary Alisha Tafoya Lucero**. “Inclusion of these secured tablets will streamline program resource expansion, advance operational efficiencies, and bring new services to our facilities.”

The rollout of the “Smart Communications” tablets will launch Monday, July 1. They will replace the current mail and telephone vendor. Key features of the tablets will include educational, vocational, and religious resources. Additionally, they will include a law library, secure legal communications, digital forms, virtual visits, electronic messaging, and entertainment options.

“We look forward to creating a model agency with New Mexico and changing the status quo of incarceration, while utilizing new technologies to focus on rehabilitation, communication, and safety,” **said Jon Logan, CEO of Smart Communications**.
